WARRANTY PROCEDURE:

To initiate a warranty claim, please contact Keystone Technologies via phone, fax, email, or mail using the following contact information: Keystone Technologies, ATTN: Warranty Claim, P.O. No.), Date of Installation, Nature of Problem, Fixture Manufacturer, Location of Installation

Keystone Technologies will contact the user, if required, for a field inspection and/or return of ballast product for laboratory testing. If a field inspection is in fact required, such service will be arranged at the sole discretion of Keystone Technologies.

If the field inspection and/or laboratory testing indicates that the ballast failed due to a manufacturing defect, Keystone Technologies will refund the purchase price of the ballast or promptly provide a replacement free of charge. All labor reimbursement claims must be presented in writing and approved by Keystone Technologies prior to any performance of labor services. Keystone Technologies maximum labor allowance is US\$10.00 per ballast. All defective ballasts must be returned to Keystone Technologies to be considered for warranty claim.

STATEMENT OF WARRANTY:

Keystone Technologies, LLC., P.O. Box 246, Ambler, PA 19002, (215) 283-2600 (hereinafter called "Keystone Technologies") warrants to the purchaser of its magnetic and electronic lamp ballasts, (hereinafter called "Ballasts") to be free of defects in material and workmanship for the specified warranty periods starting from the date of manufacture indicated on Ballast.

Commercial Grade Electronic Ballasts (75°C Operation)	5 Years
Commercial Grade Electronic Ballasts (90°C Operation)	3 Years
Residential Grade Electronic Ballasts	2 Years
Electronic Transformers	3 Years
High Intensity Discharge Ballasts	2 Years
Standard Magnetic Ballasts	2 Years

If it appears within the specified warranty period that any Keystone Technologies Ballast does not meet the warranty specified above, Keystone Technologies, at its option, will replace or repair the defective Ballast.

This warranty is not applicable if the ballast is not installed in accordance with the National Electric Code, the Standards for Safety of Underwriters Laboratories, Inc., Standards for the American National Standards Institute, or the Canadian Standards Association. This warranty is also not applicable if the ballast is not installed according to Keystone Technologies instructions or recommendations or if the product has been exposed to abnormal operating conditions including excessive temperatures.

If a customer must make a warranty claim, the Ballast shall be returned to Keystone Technologies, PO Box 246, Ambler, PA 19002 for evaluation of problem at which time Keystone Technologies will determine applicability of warranty. If the product is found to be defective under this warranty, Keystone Technologies will provide replacement Ballast(s) as necessary. A maximum of US\$10.00 may be applied to each defective ballast to apply to labor charges at the discretion of Keystone Technologies.

NO IMPLIED STATUTORY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE SHALL APPLY BEYOND THE AFOREMENTIONED WARRANTY PERIOD. The foregoing warranty is exclusive of all other statutory, written or oral warranties, and no other warranties of any kind, statutory or otherwise, are given or herein expressed.
